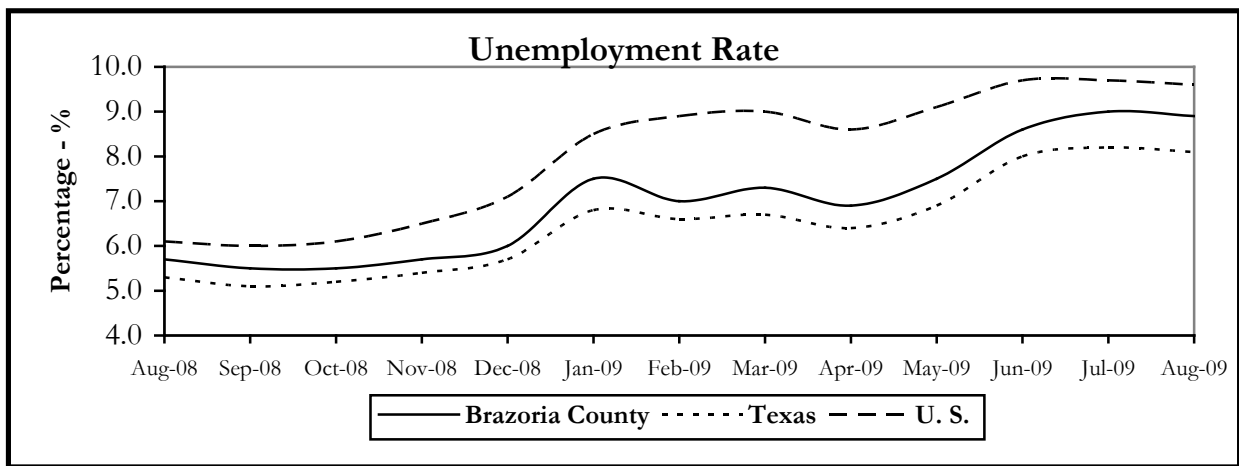


1st Quarter 2009 Data

The current rate of unemployment in Brazoria County is 8.9 percent, 3.2 percent higher than it was one year ago. The unemployment rate is higher than the state's 8.1 percent rate but lower than the nation's 9.6 percent rate. Total covered employment in the county lost 1,344 jobs over first quarter 2009, down -1.5 percent. Construction suffered the largest decline, down 1,664 jobs or -12.8 percent. Manufacturing, Professional & Business Services, and Trade Transportation & Utilities also experienced first quarter declines for a combined loss of 688 jobs. The only significant first quarter gains were in Local Government and Leisure & Hospitality, up 653 jobs and 286 jobs respectively. The county experienced a first quarter over-the-year loss for the first time since 2003, down 332 jobs or -0.4 percent from 2008, see page 3. Declines in Construction were primarily responsible for the loss, down 2,038 jobs or -15.3 percent. Professional & Business Services also incurred a significant loss of 643 jobs, down -10.3 percent. Largest job gains were in Trade Transportation & Utilities, Leisure & Hospitality, and Local Government, see page 2.

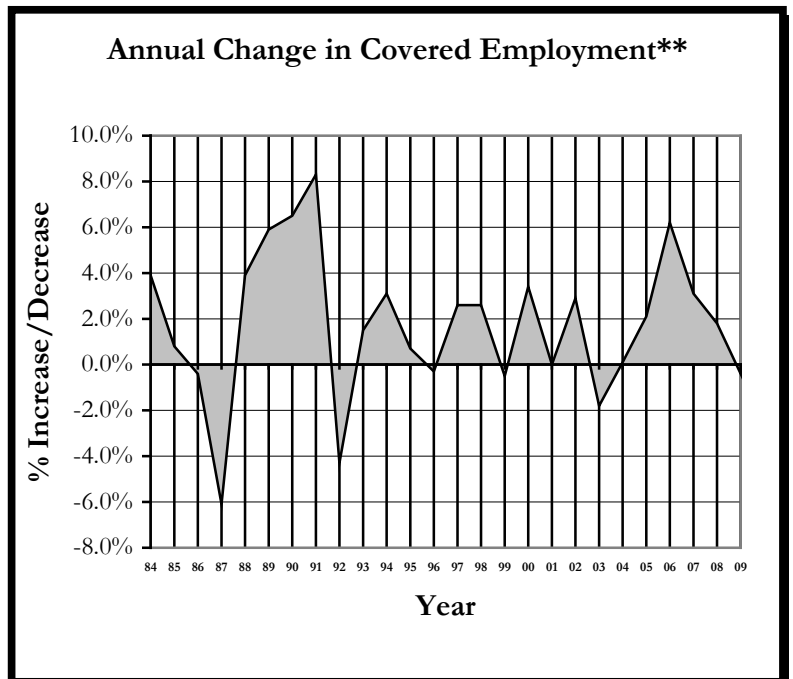
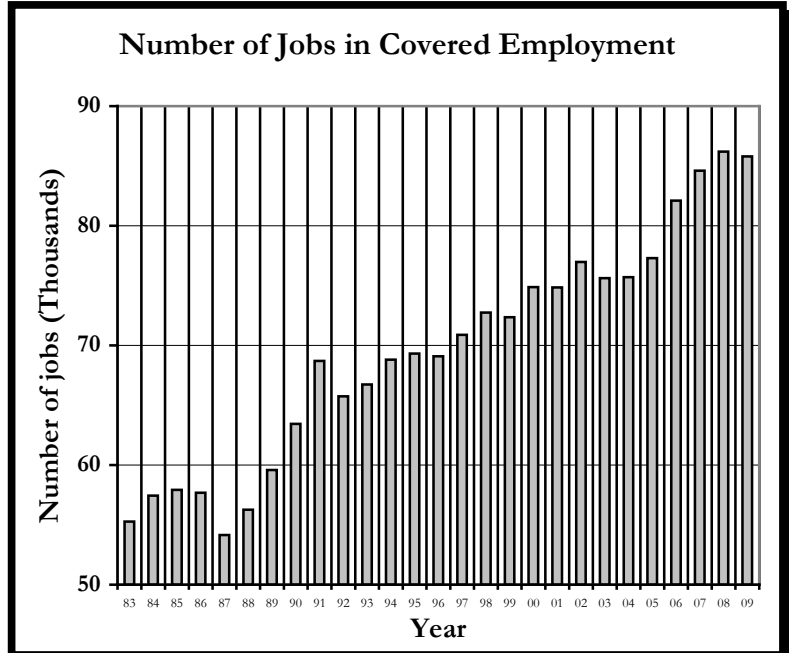

Employment is the estimate of employment based upon the sample, not the sample employment. Wages for the OES survey are straight-time, gross pay, exclusive of premium pay. Base rate, cost-of-living allowances, guaranteed pay, hazardous-duty pay, incentive pay including commissions and production bonuses, tips, and on-call pay are included. Excluded are back pay, jury duty pay, overtime pay, severance pay, shift differentials, nonproduction bonuses, employer cost of supplementary benefits, and tuition reimbursements. **The Gulf Coast Region is defined as **Austin, Brazoria, Chambers, Colorado, Fort Bend, Galveston, Harris, Liberty, Matagorda, Montgomery, Walker, Waller, and Wharton** Counties.
