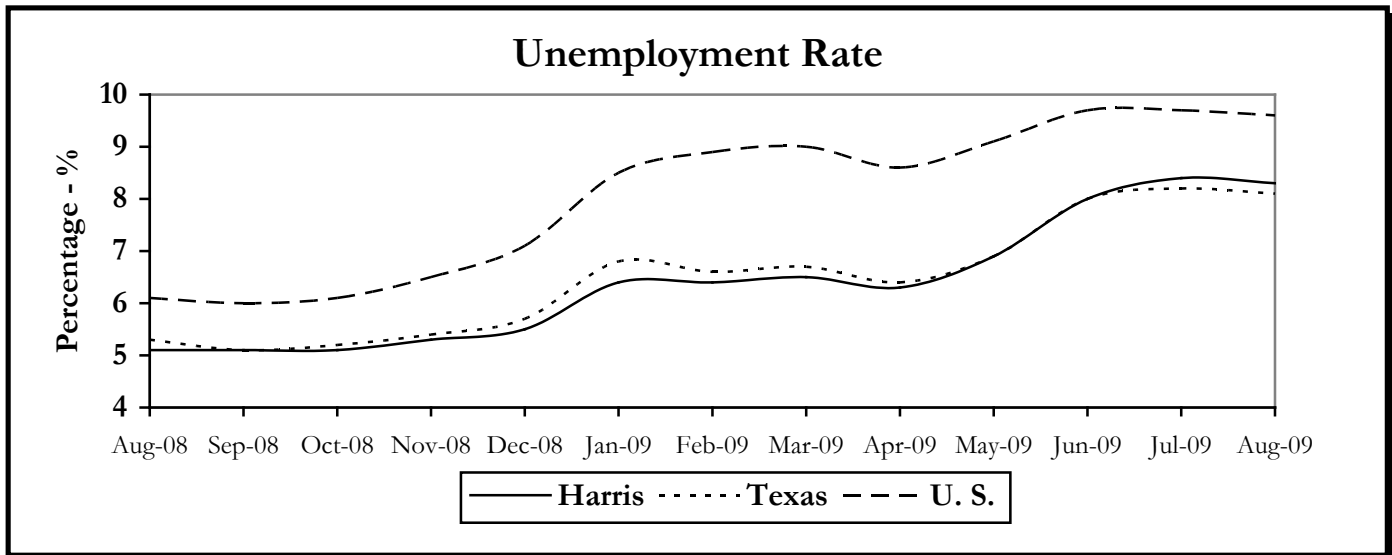


1st Quarter 2009 Data

The current rate of unemployment in Harris County is 8.3 percent, 3.2 percentage points higher than one year ago. The unemployment rate is higher than the state's 8.1 percent rate but lower than the nation's 9.6 percent rate. Total covered employment in the county suffered its largest first quarter decline since 1986, currently down 42,225 jobs - 2.0 percent from fourth quarter 2008. Hardest hit by the latest economic downturn were Professional & Business Services, down 13,806 jobs or -4.1 percent, Trade Transportation & Utilities, down -4.0 percent, and Construction, down 10,935 jobs or -6.9 percent. Over-the-year job growth in the county continued to fail adding a mere 1,962 jobs, up 0.1 percent from first quarter 2008. The rate of over-the-year job growth is down sharply from 3.0 percent one year earlier, see page 3. The largest job losses were in Professional & Business Services, down 9,439 jobs or -2.8 percent, and Construction, down 7,489 jobs or -4.8 percent. Natural Resources & Mining continued to be the county's fastest growing super sector, up 3,843 jobs or 4.8 percent.

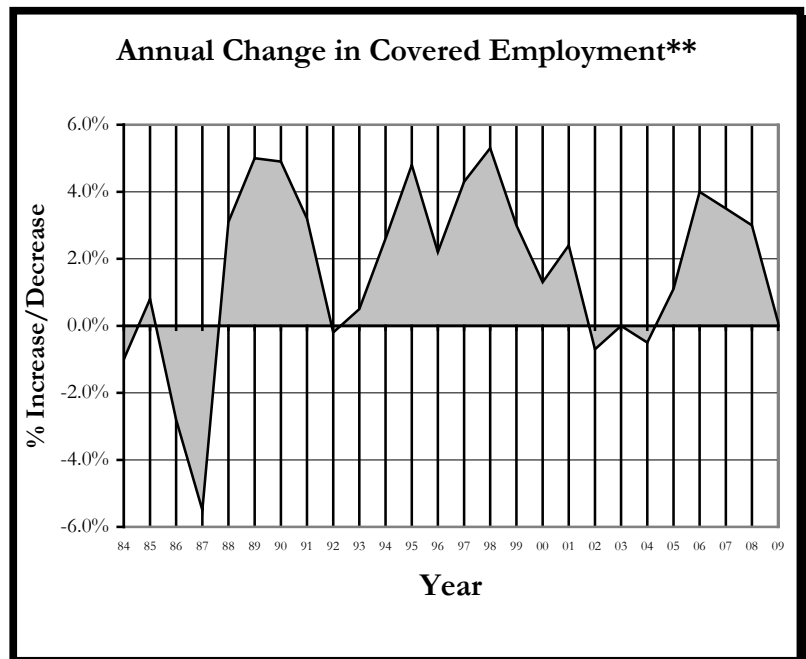
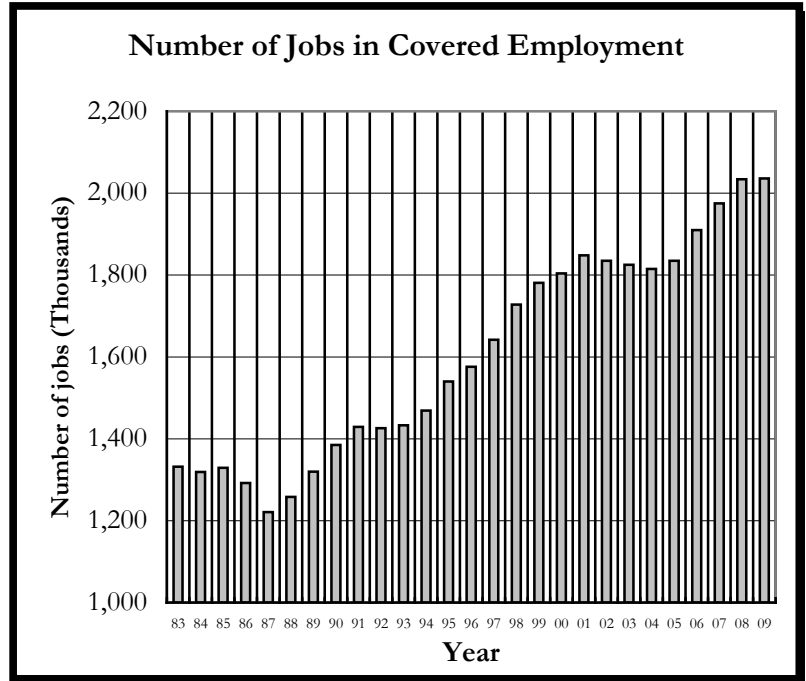

Employment is the estimate of employment based upon the sample, not the sample employment. Wages for the OES survey are straight-time, gross pay, exclusive of premium pay. Base rate, cost-of-living allowances, guaranteed pay, hazardous-duty pay, incentive pay including commissions and production bonuses, tips, and on-call pay are included. Excluded are back pay, jury duty pay, overtime pay, severance pay, shift differentials, nonproduction bonuses, employer cost of supplementary benefits, and tuition reimbursements.**The Gulf Coast Region is defined as **Austin, Brazoria, Chambers, Colorado, Fort Bend, Galveston, Harris, Liberty, Matagorda, Montgomery, Walker, Waller, and Wharton** Counties.
