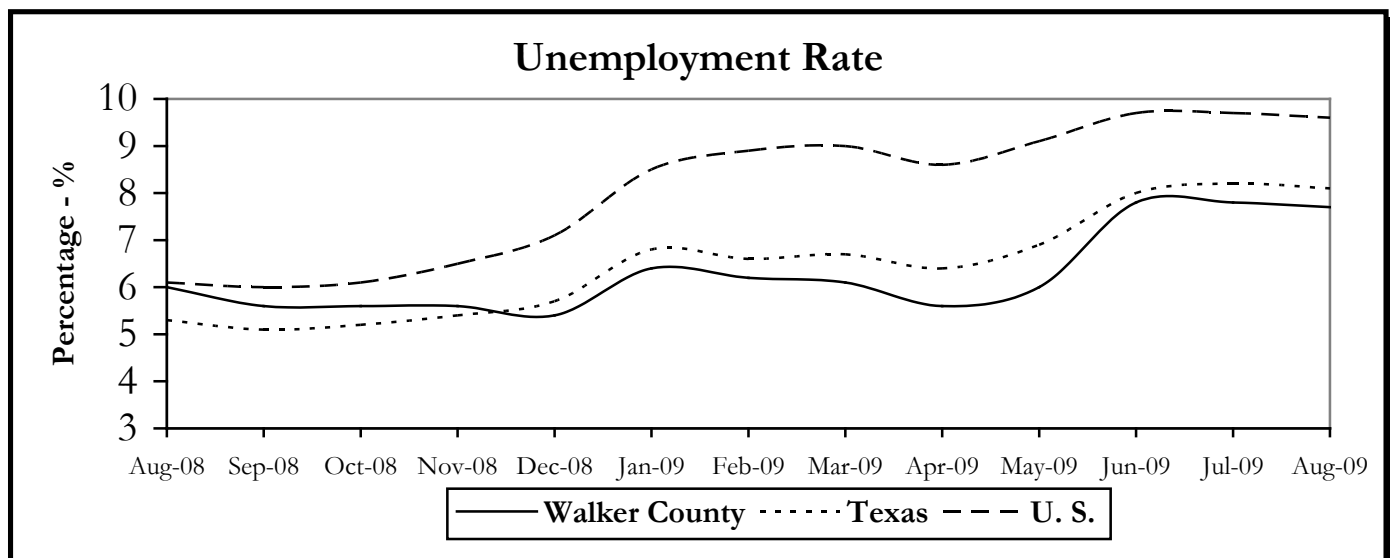

1st Quarter 2009 Data

The current rate of unemployment in Walker County is 7.7 percent, 1.7 percent higher than one year ago. The unemployment rate remains lower than the state's 8.1 percent rate and the nation's 9.6 percent rate. Total covered employment in the county lost 607 jobs over first quarter 2009, down -2.6 percent. A loss of 544 jobs in Education & Health Services was largely responsible, down -26.1 percent over the quarter, see page 2. Total covered employment in the county was down 219 jobs or -1.0 percent over the year. A loss of 522 jobs, down -25.3 percent, in Education & Health Services was responsible for the decline. Several other super sectors also experienced job losses, see page 2. An increase of 287 jobs in State Government, up 2.9 percent, helped minimize losses. Overall, growth in the county has remained stagnant since 1998, see page 3.

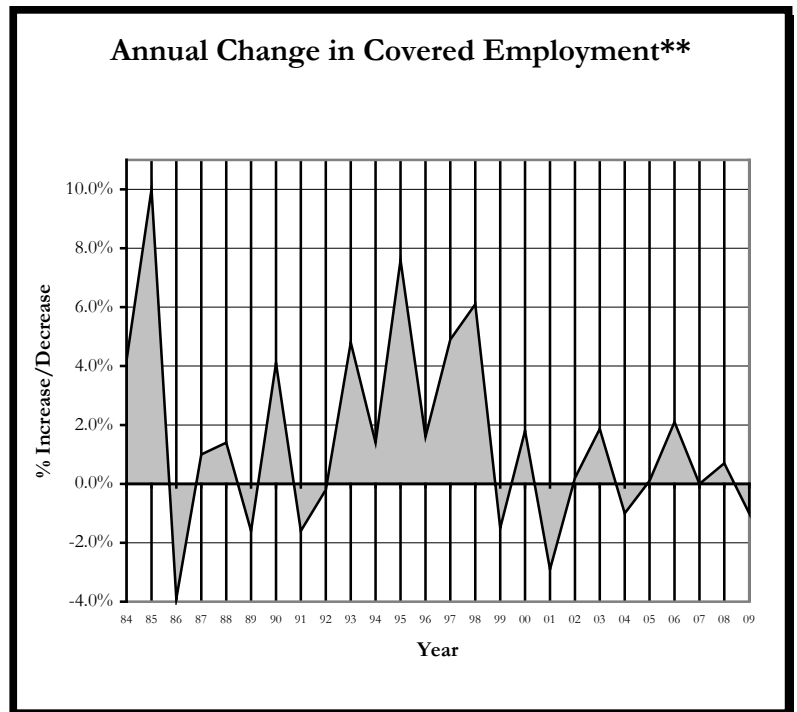
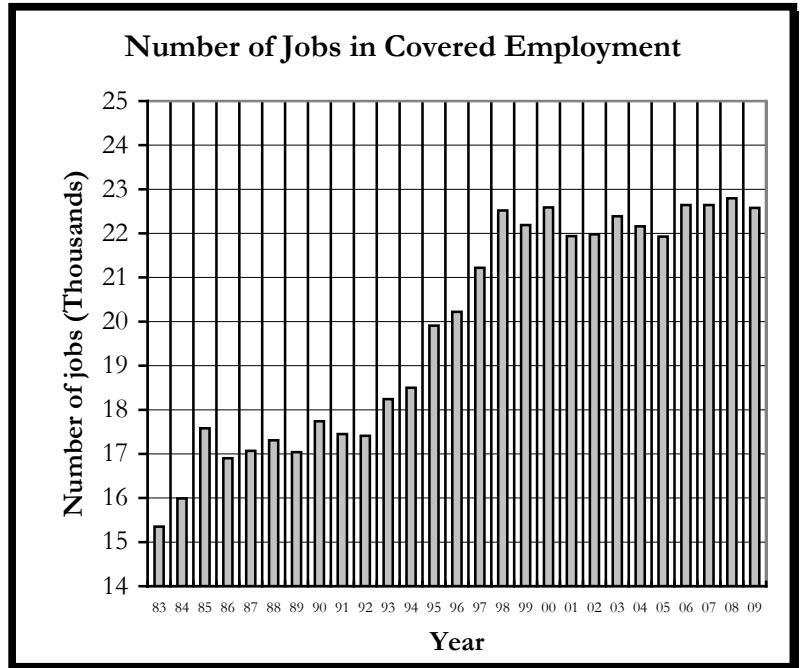

Employment is the estimate of employment based upon the sample, not the sample employment. Wages for the OES survey are straight-time, gross pay, exclusive of premium pay. Base rate, cost-of-living allowances, guaranteed pay, hazardous-duty pay, incentive pay including commissions and production bonuses, tips, and on-call pay are included. Excluded are back pay, jury duty pay, overtime pay, severance pay, shift differentials, nonproduction bonuses, employer cost of supplementary benefits, and tuition reimbursements. **The Gulf Coast Region is defined as **Austin, Brazoria, Chambers, Colorado, Fort Bend, Galveston, Harris, Liberty, Matagorda, Montgomery, Walker, Waller, and Wharton** Counties.
