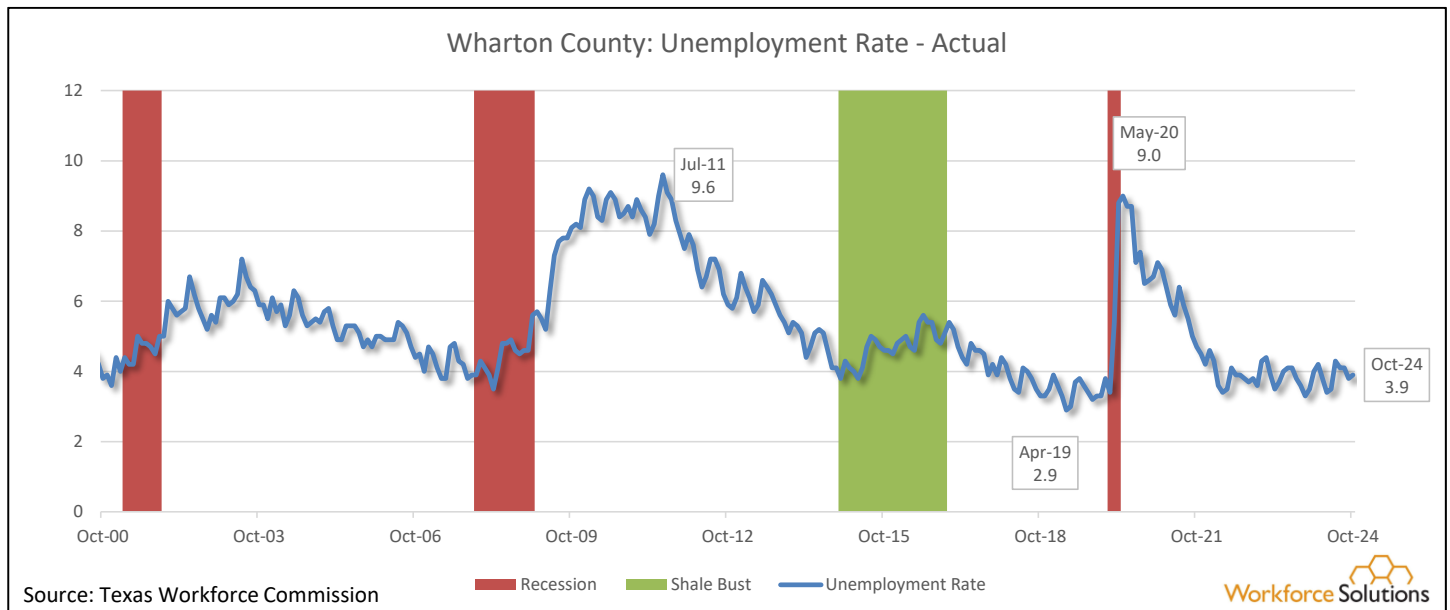

County Employment Data*

The rate of unemployment in Wharton County rose one-tenth of a percentage point to 3.9 percent in October, three-tenths of a percentage point higher than it was a year earlier. This was only the third time the rate of unemployment has risen in October since records began in 1990. The rate of unemployment in the month of October typically falls during most years as the academic year gets into full swing except during economic slowdowns or other uncommon events. The local rate of unemployment was slightly lower than 4.1 percent at the state level and the same as 3.9 percent at the national level. Total covered employment in Wharton County was down 58 jobs or 0.4 percent over second quarter 2024. This was the only second quarter decline on record excluding during the pandemic back in 2020. Notable increases were found in: Natural Resources and Mining, up 64 jobs or 3.1 percent, Leisure and Hospitality, up 40 jobs or 3.2 percent, Education and Health Services, up 38 jobs or 1.5 percent, and Construction, up 36 jobs or 5.9 percent. A loss of 186 jobs in Trade, Transportation, and Utilities, down 4.2 percent, was primarily responsible for a weak second quarter. Job growth has eroded over the last three consecutive quarter in Wharton County reporting its first over-the-year loss since the pandemic during first quarter 2021, down 101 jobs or 0.6 percent from second quarter 2023. Trade, Transportation, and Utilities takes responsibility for the loss with payrolls down 254 jobs or 5.7 percent over the year. Largest gains were found in Education and Health Services, up 83 jobs or 3.4 percent, Manufacturing, up 80 jobs or 6.0 percent, and Construction, up 45 jobs or 7.5 percent. Base rate, cost-of-living allowances, guaranteed pay, hazardous-duty pay, incentive pay including commissions and production bonuses, tips, and on-call pay are included. Excluded are back pay, jury duty pay, overtime pay, severance pay, shift differentials, nonproduction bonuses, employer cost of supplementary benefits, and tuition reimbursements. **The Gulf Coast Region is defined as Austin, Brazoria, Chambers, Colorado, Fort Bend, Galveston, Harris, Liberty, Matagorda, Montgomery, Walker, Waller, and Wharton Counties.
