

#### **County Employment Data\***

The rate of unemployment in Wharton County was unchanged at 4.1 percent in Augst, the same as it was a year earlier. The local rate of unemployment was lower than 4.4 percent at the state and national level. Total covered employment in Wharton County was down 195 jobs over first quarter 2024. The 1.2 percent decline was the largest first quarter decline in three years. A larger than normal seasonal decline in Trade, Transportation, and Utilities was primarily responsible for the weakness, down 230 jobs or 5.0 percent. Trade, Transportation, and Utilities typically incurs a seasonal decline of around 0.9 percent. Natural Resources also contributed to the decline although it reports a loss during most years, down 117 jobs or 5.4 percent. Helping offset losses were substantial increase in Education and Health Services, up 150 jobs or 6.4 percent, and Manufacturing, up 102 jobs or 7.6 percent. Wharton County added 478 jobs over the year with payrolls up 3.0 percent from first quarter 2023, down from 4.1 percent in fourth quarter 2023. Most of the increase was in Education and Health Services, up 193 jobs or 8.4 percent, Trade, Transportation, and Utilities, up 110 jobs or 2.6 percent, and Manufacturing, up 102 jobs or 7.6 percent.
